Memorandum of Understanding
Between
Radboud University
And
Diponegoro University

To promote understanding and goodwill, to strengthen cultural ties, to broaden student and faculty experience and horizons, Radboud University, Nijmegen, the Netherlands, represented by its President, Prof. dr. G.J.M. Meijer, and Diponegoro University, Semarang, Indonesia, represented by its Rector, Prof. Dr. Yos Johan Utama, hereby enter into the following Agreement:

Article 1

The contracting Parties will strive to deepen the existing relations in the sphere of scholarly cooperation and to develop new relations on the principle of mutual benefit and full reciprocity.

Article 2

The cooperation will involve all Faculties of Radboud University and all Faculties of the Diponegoro University.

Article 3

Both Parties will consider an exchange of academic staff and/or students based on reciprocity. Applications of candidates, including outlines of the program to be carried out abroad, are subject to the approval of the receiving University. Both Parties will promote and sponsor joint research projects in areas where their interests correspond, subject to the availability of funds.

Article 4

Both Parties will consider the possibility of organizing conferences, symposia, seminars, summer school courses and workshops.

Article 5

Both Parties agree to promote the development of relationships between the central libraries and to establish a regular exchange of publications by the two Universities.

Article 6

The Faculties involved of both Universities will review the details of the programs of cooperation and the progress of the cooperation annually.

Article 7

Diponegoro University and Radboud University agree to consider undertaking joint activities to raise funds for the activities planned. Both Parties will try to use existing financial sources such as bilateral governmental agreements and exchange programs. Any agreed tuition waivers will be set out in the student exchange agreement bettered into between the Parties.

Article 8

Any changes and amendments in the text of the said Agreement shall be introduced only in writing and after the prior mutual consent of authorized representatives of both Parties. These changes and amendments shall be treated as integral parts of the Agreement.

Article 9


In the event that any term or provision of the Agreement will be considered invalid, void or unenforceable by any competent authority, such a decision shall, in terms of such invalidity or non-enforceability, be interpreted strictly without affecting the validity of any other provision of this agreement.


Article 10

This Agreement comes into force upon signing and continues in force for a five years period, renewable by explicit agreement. The Agreement can be canceled by either of the Parties with a six-month advance notice or modified at any time by mutual agreement.
